"Implementing Quality Measures for Public Health Nursing Practice: New **Tools and Revised Competencies**"

Ensuring a strong and competent workforce in public health is critical to creating healthy communities and organizational quality. The Quad Council Public Health Nursing Competencies (QCCPHNC) are the standard for public health nurses in the United States. In May 2018 the Quad Council released revised QCCPHNCs and tools for implementing the competencies. BREAKOUT WORKSHOPS 11:30 am

"Culture Independent Diagnostic Testing (CID) and Carbapenem Resistant Enterobacteriacae (CRE)"

Exploring new testing technologies and discussing their impact on Public Health's response to disease intervention this session will cover these two topics separately based on the significant changes to public health laboratory testing that each of them are creating and what it means for LPHAs and clinical laboratories as well. CIDTs can be rapid, reliable and inexpensive way for a patient diagnosis. Specific CIDTs that are Multiplex PCR panels for Stool, blood, CSF and respiratory specimens have the ability to test a wide array of pathogens with similar symptoms in the same tube. CIDT samples for testing do not require culture isolation. Public health uses the culture isolation for surveillance (both in detecting outbreaks and determining trends such as virulence factors and antimicrobial resistance) and outbreak investigation (serotyping and subtyping). Isolate testing ultimately leads to stopping the spread of an outbreak and disease prevention which is critical to public health disease response. CREs are a growing threat to the general public's health and one of the most significant areas of concern for antimicrobial resistance (AR). They are resistant to nearly all possible therapeutic agents. Their resistance mechanisms (specifically Carbapenemases) are easily transferred to other bacteria. The federal government is aiding the creation of state-based capacity to detect Carbapenemase producing CREs to improve the ability to implement timely local prevention efforts and to develop national strategies that limit transmission of resistant pathogens.

"Sharing Data and Public Health 3.0: The What, Who, Why and How"

Building healthy communities requires access to relevant data from multiple sectors, including public health, healthcare, schools, human services, housing, and law enforcement. Data are essential for identifying health threats, designing interventions, coordinating care, measuring what works and planning for policy, systems and environmental change. A complex legal landscape, and lack of knowledge and training in law, result in actual and perceived barriers to data collection, use, and sharing. This presentation will describe strategies to promote a good working relationship with legal counsel in order to work together to solve legal issues to allow data sharing; list factual information about a data sharing initiative that an attorney needs in order to provide legal analysis and counsel; discuss approaches that allow healthcare providers and public health agencies to legally share necessary data with community-based organizations to address determinants of health and promote health equity; and provide a systematic approach for agencies and their attorneys to analyze a data sharing issue, navigate law, and identify safeguards to share the most meaningful data possible while protecting privacy and maintaining trust.

"Communicable Disease Outbreak Detection, Investigation, and Response"

Communicable disease outbreaks related to food, animals, or other common source exposures often include cases from multiple jurisdictions and require a multidiscipline investigation to identify the source and to promptly implement the necessary control measures. The purpose of this presentation is to provide an overview and insight into how these outbreaks are identified and investigated. In addition, specific outbreaks will be discussed to highlight the critically important collaboration of the various disciplines of epidemiology, laboratory, and environmental public health at the local, state, and national levels are to ensuring a prompt and successful public health response.
